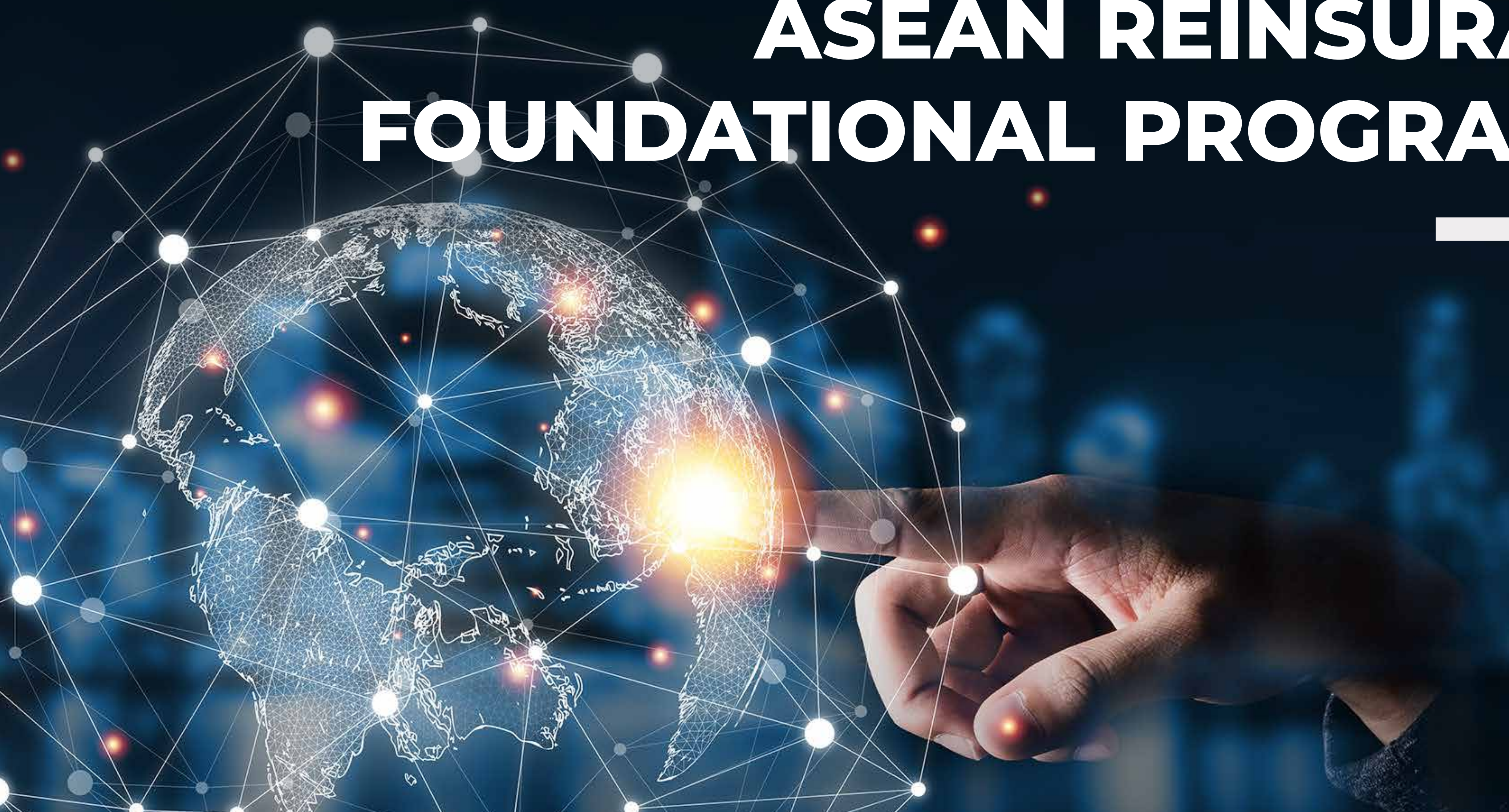

Recognition of Prior Learning (RPL) credits awarded by the Chartered Insurance Institute (CII)

With effect from 11 September 2013, all candidates who pass the CRI examination are eligible to apply for 15 Certificate-level non-unit specific credits in the CII Insurance qualifications framework.

Please take note that the above-mentioned CII RPL Credits are valid until 31 January 2022.

ABOUT THE CERTIFICATE

The Certificate Course aims to provide participants with a fundamental knowledge of the functions and the fundamental principles of reinsurance, the terms and concepts as reflected in the various types of treaty accounts documents, the concept and functions of life reinsurance, the various forms of reinsurance, the different forms of reinsurance arrangement and the common treaty clauses in proportional and non-proportional treaties. Through a combination of on-line lectures and mock exam exercise, it culminates in candidates taking the Certificate In Reinsurance examination conducted by SCI. Successful candidates will be awarded the Certificate In Reinsurance. Examinations will be held on the last day of every month from 10am (SGT Time) to 12 noon (SGT Time).

Eligibility criteria to pay the above Net Fee:
Only Singapore Citizens or Singapore Permanent Residents who are physically based in Singapore and are sponsored by a Financial Institution are eligible for funding.
